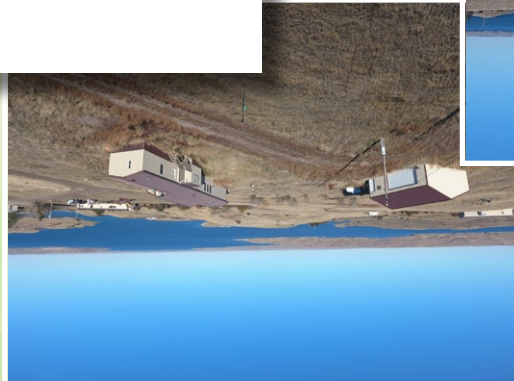

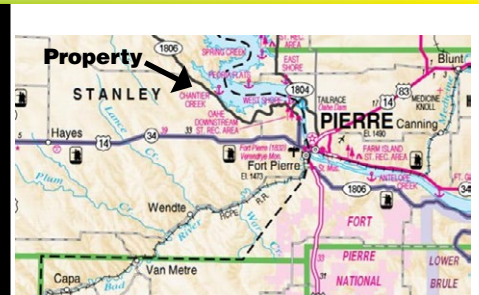

-The popular Chantier Creek Resort with store, bar, café, lodging and boat storage on 5.23 acres located at 20215 N Hwy. 1806, Ft. Pierre SD. The main store/bar/café is an a 3600 sq.ft. steel/wood structure with room for store inventory, bar, tables, pool table, etc. as well as restrooms and storage. The remaining, approx. ½ of the building is cold storage for boats, etc. with 3 overhead doors. Also includes a front awning and spacious rear deck with spectacular view of Lake Oahe. The adjacent 4 unit motel includes 4, modest 16x16' sleeping rooms with individual decks and a laundry room. Includes all owned fixtures and equipment currently onsite as well as current Stanley Co. Malt Beverage license. Water is supplied by WRLJ Rural Water and has a septic system. The facility is conveniently located on Hwy. 1806, just ¾ mile from the Chantier Creek boat launch area. The sale does NOT include the adjacent RV Park.

-Lake Home on 5.56 acres overlooking Lake Oahe at 20228 N. SD Hwy. 1806 (adjacent to the Chantier Creek Resort). Features an 1140 sq. ft. mobile home on partial walkout basement. Other improvements include a deck and entryway as well as a 32'x32' steel garage for boat/ATV/vehicle storage. Water by WRLJ Rural Water and includes septic system. Selling as 2 separate lots of 4 & 1.56 acres, making for additional development possibilities. This home appears to be in fair condition, and may require some repairs/upgrades/finish work to occupy.
